#### • Problem and Need

Thailand Credit Union Network is the most strengthen of the network if compare with other Cooperative network, because we have a while network connection namely: Global Network (WOCCU, GWLN), Asian Network (ACCU, AWCF), National Federation Credit Union (CULT), and Credit Union Primary (CUs).

How to get more member involvement with this Network, special for women credit union?

The Global Women Leadership's Network, WOCCU is a world while network among women in Credit Union. They have many ways to have more connection, learning and sharing among the Global Women who have a lot of expertise of each section.

The Association of Asian Confederation of Credit Union (ACCU) is partner of WOCCU. ACCU works in partnership with its members in 22 countries to strengthen and promote credit unions as effective instruments of socio-economic development of the people. As a development organization, ACCU addresses the issue on Women participation in credit unions since 1982. It has included in its structure a Women Advisory Committee that meets annually in conjunction to the Annual General meeting. The committee provides inputs on women issues that need to be addressed in credit unions. In 2015, ACCU has supported the organization of Sister Society in Asia. It has helped organize the Sister Society in the Philippines, Nepal and Thailand. ACCU believes the Sister Society can accelerate its initiatives on women empowerment by connecting Asian women globally. It believes the network can offer encouragement, self-confidence and professional development to Asian credit union women.

The Asian Women in Co-operative Development Forum (AWCF) is a resource center and advocacy body on gender and co-operatives in Asia, Its members in Indonesia, Malaysia, Philippines, Thailand, Cambodia and Vietnam are national co-op





organizations and non-government organizations (NGOs) that promote co-operatives. AWCF functioned initially as an informal, collaborative forum among its founding organizations. It promoted gender awareness among these organizations' female and male leaders, staff, and members so as to enable them to pursue the thrusts of AWCF. AWCF is also a member of the Regional Women Committee of International Cooperative Alliance in Asia Pacific (ICA-AP).

Credit Union League of Thailand, LTD. (CULT) is ACCU's member and also AWCF's member. CULT is a national organization initiated by the private sector in 1972. CULT brings together more than 1,230 Thai credit union groups, with more than 1,300,000 individual members, with women comprising more than 60 percent of the membership, as of year 2014. CULT works toward developing a strong and viable credit union (CU) movement in Thailand founded on the values of commitment, honesty, sacrifice, responsibility, sympathy, and trust, to promote self-help and mutual help to achieve human development and peace. Toward this, CULT seeks to develop CUs as the main financial institution in the community. Thus it commits itself to delivering excellent financial services and other services that will respond to both the social and economic needs of the members.

CULT's programs and activities include education and training, bookkeeping and accounting, dormitory and meeting room services, CU chapters' promotion, women and youth development, mutual aid in CU, business enterprise development, information technology, and research and publications.

Since 1998, CULT has been addressing the role and participation of women in co-ops. In fact, part of its organizational structure is a Gender and Development (GAD) Committee that serves as advisory body on gender concerns to the CULT Board and General Assembly. Meanwhile, CULT's Women Co-operative Products Development Center (WCPC) helps sustain women co-ops' initiatives to create and develop products, for instance, through support in marketing and product development and design.

In 2013, CULT's Board of Director appointed the Women Committee to work closely with Education Department for developing women in Thailand. In 2014, CULT set up the Women Credit Union Chapter to strengthen and promote the women program and services. There are many women programs, activities and success stories which working and promotes with the cooperation between Women Committee and Women groups in Credit Union in all regions across Thailand which supports by Credit Union Development Institute belong to CULT.

In 23 April 2015, Credit Union in Thailand set up the Thailand Sister Society with this great event, Ms Brianne Hurford, WOCCU Communications & Development Manager gave a video message to the women which showed them that they were now really connected to the credit union world and could help to make a difference in their lives, their members' lives and their communities.
